### COUNCIL STRATEGIC GOALS

Goals and priorities were created through an informed and collaborative approach. The organization was engaged to gather information and evaluate relevant documents, policies, strategies and frameworks. A PESTLE (Political, Economic, Social, Technological, Legal and Environmental) analysis was used to consider current and potential factors. During the COVID-19 pandemic, in-person public consultation was not possible. However, to be fully representative, the public was invited to complete an online survey to share:

- How they thought the draft goals support the vision of becoming Canada's most livable community.
- How focusing on priorities between 2023-2026 would help the County support each goal.
- What else the County should consider to support each goal.



After considering the input from members of the public and County employees, Council created goals and priorities for the 2023-2026 Strategic Plan. A key consideration is that all goals are equally important in moving towards our vision and there are many dependencies between the priority areas. To champion an integrated approach, the goals depicted are consistent between all levels of planning such as the corporate business plan, departmental plan, and our financial plan, the budget.


